The All Exporters of Sugar (raw, white and refined sugar).

Subject: Data regarding sugar lifted/dispatched from the sugar mills for export prior to 01.06.2022 but yet to be shipped.

Sir,

Reference is invited to the DFPD's letters dated 05.06.2022 and 06.06.2022 vide which combined export release orders to exporters and sugar mills have been issued.

2. It has come to the notice of the Directorate of Sugar and Vegetable Oils that there are cases where exporters had lifted sugar from the sugar mills on or before 31.05.2022; but, the sugar has not yet been shipped / exported.

3. Exporters are advised to intimate this Directorate about such quantity, type of sugar (raw or white/refined) the name of the sugar mill (s) and its plant code from which sugar has been lifted and the date (s) on which the sugar was lifted from the sugar mills for export. The exporter shall submit an undertaking stating that the lifting/dispatch was done prior to 01.06.2022 and sugar is in transit and yet to be shipped. In case, ERO has been issued to the exporter, then the same may also be intimated along with the quantity for which ERO has been issued and the balance quantity for which ERO is yet to be issued. The information may be submitted by 23.06.2022 positively in the attached proforma (in MS Excel) through email at sugarexports-fpd@gov.in.

4. Exporters are required to furnish details in respect of only that quantity of sugar which has been lifted from sugar mills prior to 01.06.2022, but yet to be shipped/exported & for which the exporter can submit (when required) the proof of lifting of sugar prior to 01.06.2022 i.e. copies of railway receipts or e-way bills, factory invoice, relevant GSTR of sugar mill & GSTR of exporter confirming lifting of sugar prior to 01.06.2022
