**Subject:- Submission of UC's under buffer & export subsidy schemes-reg**

Madam/Sir,

As you are aware that assistance has been released to eligible sugar mills under various schemes during last few years.

2. In this connection, all sugar mills were advised vide this office letters No. 5-3/2013-CC-II dated 08.04.2022 & 17.05.2022 (copy enclosed) that as per the notifications of above said schemes, all the sugar mills to whom assistance have been released are required to submit Utilization Certificates within three months from the date of release of funds to the sugar mill and also required to upload its expenditure details on the PFMS module. Further, all sugar mills which were availing benefits under buffer stock schemes were also advised vide this directorate letter dated 18.02.2022 (copy enclosed) that the sugar mills would be required to submit the UCs for the entire disbursed amount within 3 months from the date of disbursement of funds, failing which, the buffer subsidy amount shall be recovered from the concerned sugar mill along with the Interest at the rate as notified by the Central Government plus penal interest @2.5% per annum. Further, In case of non submission of UCs by the mill within 3 months, then at least 25% of the quantity of sugar from monthly release quota of that sugar mill would be deducted till the submission of UC's.

3. Therefore, you are requested to coordinate with sugar mills of your State (as per annexure) to ensure submission of the Utilization Certificate for each payment released to mill within three months from the date of release of funds (which is before or in June 2022) and to upload the expenditure on EAT-02 module of PFMS under the buffer subsidy schemes as well as export subsidy schemes failing which action mentioned at Para 2 above would be taken against the concerned sugar mills.

Sir,

As you are aware that assistance has been released to eligible sugar mills under following schemes:

1. Scheme for Assistance to Sugar Mills for 2018-19 season.
2. Scheme for Assistance to sugar Mills for expenses on marketing costs including, upgrading and other processing costs and costs of international and internal transport and freight charges on export of sugar for 2019-20 season.
3. Scheme for Creation and Maintenance of Buffer Stock of 40 Lakh MT of sugar by sugar mills in the country for one year.
4. Scheme for Creation and Maintenance of Buffer Stock of 30 Lakh MT of sugar by sugar mills in the country for one year.
5. Scheme for defraying expenditure towards internal transport, freight, handling and other charges on export. (for 2018-19 Season)
6. Scheme for Assistance to sugar Mills for expenses on marketing costs including, upgrading and other processing costs and costs of international and internal transport and freight charges on export of sugar for 2020-21 season.

2. As per the notifications of above said schemes, all the sugar mills to whom assistance have been released are required to submit Utilization Certificates within three months from the date of release of funds to the sugar mill and also required to upload its expenditure details in the PFMS module. Further, all sugar mills which were availing benefits under buffer stock schemes were advised vide this directorate letter dated 18.02.2022 (copy enclosed) that the sugar mills would be required to submit the UCs for the entire disbursed amount within 3 months from the date of disbursal of funds, failing which, the buffer subsidy amount shall be recovered from the concerned sugar mill along with the Interest at the rate as notified by the Central Government plus penal interest @2.5% per annum. Further, In case of non submission of UCs by the mill within 3 months, then at least 25% of the quantity of sugar from monthly release quota of that sugar mill would be deducted till the submission of UC's.

3. Therefore, in view of above you are once again advised to submit the Utilization Certificate for each payment released to your mill within three months from the date of release of funds and to upload the expenditure on EAT-02 module of PFMS under the buffer subsidy schemes as well as export subsidy schemes failing which action mentioned at Para 2 above would be taken against the sugar mill.



In this connection, you are advised vide this office letter even dated 17.05.2022 that as per the notifications of above said schemes, all the sugar mills to whom assistance have been released are required to submit Utilization Certificates within three months from the date of release of funds to the sugar mill and also required to upload its expenditure details in the PFMS module. Further, all sugar mills which were availing benefits under buffer stock schemes were also advised vide this directorate letter dated 18.02.2022 (copy enclosed) that the sugar mills would be required to submit the UCs for the entire disbursed amount within 3 months from the date of disbursal of funds, failing which, the buffer subsidy amount shall be recovered from the concerned sugar mill along with the Interest at the rate as notified by the Central Government plus penal interest @2.5% per annum. Further, In case of non submission of UCs by the mill within 3 months, then at least 25% of the quantity of sugar from monthly release quota of that sugar mill would be deducted till the submission of UC's.

3. Therefore, in view of above you are once again advised to submit the Utilization Certificate for each payment released to your mill within three months from the date of release of funds and to upload the expenditure on EAT-02 module of PFMS under the buffer subsidy schemes as well as export subsidy schemes failing which action mentioned at Para 2 above would be taken against the sugar mill.
