Export Release Order-2

Subject: Combined Export Release Order for Exporters where exporters had lifted sugar from the sugar mills on or before 31.05.2022; but, the sugar has not yet been shipped / exported.

Whereas, DGFT vide notification dated 24.05.2022 has placed Sugar (Raw sugar, Refined sugar & White sugar) bearing ITC (HS) Code 17011490 & 17019990 in "Restricted" category for exports. Further, DFPD vide letters of even number dated 24.05.2022 has issued letters to sugar mills as well as exporters along with the guidelines/procedure for applying/obtaining Export Release Order (ERO) for sugar mills and exporters.

- 2. Whereas, DFPD vide letters dated 05.06.2022 and 06.06.2022 has issued combined export release orders to exporters and sugar mills respectively.
- 3. Whereas, exporters were advised to intimate this Directorate about quantity, type of sugar (raw or white/refined) the name of the sugar mill from which sugar has been lifted from the sugar mills for export wherever the lifting/dispatch was done prior to 01.06.2022 and sugar is in transit and yet to be shipped.
- 4. Whereas, large quantity of sugar has been lifted from sugar mills and is in transit/lying in port area and has not been shipped due to restrictions on export; and as it is not financially viable to bring back that sugar, therefore, it has been decided to issue EROs to facilitate such exporters to export sugar in the current Sugar Season 2021-22.
- 5. Therefore, Directorate of Sugar and Vegetable Oils, Department of Food and Public Distribution, Ministry of Consumer Affairs, Food and Public Distribution, in exercise of powers conferred by section 3 of the Essential Commodities Act, 1955 (10 of 1955) read with clause 4 and 5 of the Sugar (Control) Order, 1966, hereby, grant permission to exporters to export sugar which has been lifted from the sugar mills for export prior to 01.06.2022, within 45 days from the date of this order as mentioned in the **Annexure (exporter wise)** subject to the following conditions:

- a. Exporters shall submit proof to custom authorities about lifting of sugar from sugar mills prior to 01.06.2022 i.e. copies of railway receipts or e-way bills, factory invoice, relevant GSTR of sugar mill & GSTR of exporter confirming lifting of sugar prior to 01.06.2022.
- b. The exporter shall submit a report of implementation of Release Order after completion of such export to the Chief Director (Sugar).
