**Subject:** Furnishing of actual stock position of sugar as on 30.09.2022 by 10<sup>th</sup> October, 2022.

Sir/Madam.

It has come to knowledge of this Department that the month end stock position is not being correctly reflected by some sugar mills in the online P-II. The discrepancies in the data may affect the appropriate decision making by this Department.

- 2. As a special one-time measure to facilitate all sugar mills to rectify their data, all the sugar mills need to furnish actual stock position as on 30.09.2022 by 10<sup>th</sup> October, 2022 (as per enclosed proforma). The report should be signed by the Chartered Accountant (CA) of the Mill/Society/Company which will further be duly certified by the officers of Cane Commissioner of the respective State. Further, actual stock position duly signed by Chartered Accountant and verified by CEO/MD of the sugar mill may also be furnished to the directorate of Sugar through email <a href="mailto:sugarcontrol-fpd@gov.in">sugarcontrol-fpd@gov.in</a> earliest by 10<sup>th</sup> October,2022.
- 3. It is also informed that as a one-time special measure, no penal action under the Essential Commodities Act 1955 will be taken against any mill for discrepancy in the data earlier submitted by the mill.
- 4. However, it may be noted that in absence of the report duly certified by the Cane Commissioner or his nominated Officer as mentioned at Para 2 above, no domestic release will be given to the concerned mill for November 2022 onwards. Further, any discrepancy in the physical stock with the mill and as reported to the Directorate of Sugar and Vegetable Oils in future may attract strict penal action against the sugar mill.
