Export Release Order for Sugar Mill – Source mill name change


Whereas, DGFT vide notification dated 24.05.2022 has placed Sugar (Raw sugar, Refined sugar & White sugar) bearing ITC (HS) Code 17011490 & 17019990 in "Restricted" category for exports. Further, DFPD vide letters of even number dated 24.05.2022 has issued letters to sugar mills as well as exporters along with the guidelines/procedure for applying/obtaining Export Release Order (ERO) for sugar mills and exporters.

2. Whereas, DFPD has issued Export Release Orders (EROs) to exporters and sugar mills vide letters of even No. on various dates, uploaded on DFPD website i.e. <https://dfpd.gov.in/index.htm>.

3. Whereas, the Directorate of sugar vide order dated 05.08.2022 issued orders to sugar mills/exporters w.r.t various contracts for sugar have been executed between exporter from India and importers from Sri Lanka. Now, the exporter M/s. Sai Export Agency has requested to change the source sugar mill from Khardi/68401 to Kamalabhavani/69025 for ERO quantity of 4190 MT.

4. Directorate of Sugar and Vegetable Oils, Department of Food and Public Distribution, Ministry of Consumer Affairs, Food and Public Distribution, in the exercise of powers conferred by Section 3 of the Essential Commodities Act, 1955 (10 of 1955) read with clause 4 and 5 of the Sugar (Control) Order, 1966, permission is granted to M/s. Vitthal Refined Sugar Ltd, Kamalabhavani/69025 for a quantity of **4190 MT (Four Thousand One Hundred Ninety only)** of sugar to export with respective exporter M/s. Sai Export Agency (IEC - BFFPC7737F) by 31.10.2022. No separate ERO for the exporter will be issued.

5. The exporter shall submit a report on the implementation of the Release Order through email.
