## **Export Release Order for Sugar Mills**

**Subject:** Combined Export Release Order to sugar mills whose exporters have received advance payment from overseas buyers.

Whereas, DGFT vide notification dated 24.05.2022 has placed Sugar (Raw sugar, Refined sugar & White sugar) bearing ITC (HS) Code 17011490 & 17019990 in "Restricted" category for exports. Further, DFPD vide letters of even number dated 24.05.2022 has issued letters to sugar mills as well as exporters along with the guidelines/procedure for applying/obtaining Export Release Order (ERO) for sugar mills and exporters.

- 2. Whereas, DFPD has issued Export Release Orders (EROs) to exporters and sugar mills vide letters of even No. on various dates, uploaded on DFPD website i.e. https://dfpd.gov.in/index.htm.
- 3. Whereas, representations have been received from various sugar mills whose exporters have received advance payment from overseas buyers. Directorate of Sugar and Vegetable Oils, Department of Food and Public Distribution, Ministry of Consumer Affairs, Food and Public Distribution, in exercise of powers conferred by Section 3 of the Essential Commodities Act, 1955 (10 of 1955) read with clause 4 and 5 of the Sugar (Control) Order, 1966, hereby, grant permission to sugar mills to export a total quantity of 16308 MT (Sixteen Thousand Three Hundred and Eight Metric Tons only) of sugar by 31.10.2022 as mentioned in the **Annexure**.
- 4. The sugar mill shall submit a report of implementation of Release Order after completion of such export to the Director (Sugar).
