Export Release Order for Sugar Mill – Source mill name change

Whereas, DGFT vide notification dated 24.05.2022 has placed Sugar (Raw sugar, Refined sugar & White sugar) bearing ITC (HS) Code 17011490 & 17019990 in "Restricted" category for exports. Further, DFPD vide letters of even number dated 24.05.2022 has issued letters to sugar mills as well as exporters along with the guidelines/procedure for applying/obtaining Export Release Order (ERO) for sugar mills and exporters.

2. Whereas, DFPD has issued Export Release Orders (EROs) to exporters and sugar mills vide letters of even No. on various dates, uploaded on DFPD website i.e. <https://dfpd.gov.in/index.htm>.

3. Whereas, DFPD vide order dated 13.09.2022 issued EROs for sugar mills/exporters w.r.t. advance received from overseas buyers. Now, the exporter M/s SCM Agrotech Enterprises Pvt Ltd has requested to change the source mill from Bhima/14701 to Anuraj/60101 for a quantity of 536 MT and Dharikheda/40901 to Hemarus/64901 for a quantity of 394 MT.

4. Directorate of Sugar and Vegetable Oils, Department of Food and Public Distribution, Ministry of Consumer Affairs, Food and Public Distribution, in the exercise of powers conferred by Section 3 of the Essential Commodities Act, 1955 (10 of 1955) read with clause 4 and 5 of the Sugar (Control) Order, 1966, permission is granted to Anuraj/60101 and Hemarus/64901 for a quantity 536 MT (Five Hundred Thirty-Six only) and 394 MT (Three Hundred Ninety Four only) of sugar to export with respective exporter M/s SCM Agrotech Enterprises Pvt. Ltd (IEC– 1116500060) by 31.10.2022.

5. The exporter shall submit a report on the implementation of the Release Order through email.
