**Export Release Order for Nepal**

Whereas, DGFT vide notification dated 24.05.2022 has placed Sugar (Raw sugar, Refined sugar & White sugar) bearing ITC (HS) Code 17011490 & 17019990 in "Restricted" category for exports. Further, DFPD vide letters of even number dated 24.05.2022 has issued letters to sugar mills as well as exporters along with the guidelines/procedure for applying/obtaining Export Release Order (ERO) for sugar mills and exporters

2. Whereas, DFPD has issued Export Release Orders (EROs) to exporters and sugar mills vide letters of even No. on various dates, uploaded on DFPD website i.e. <https://dfpd.gov.in/index.htm>.

3. Whereas, recommendation has been received from Ministry of External Affairs for export of 3710 MT sugar to Nepal.

4. Directorate of Sugar and Vegetable Oils, Department of Food and Public Distribution, Ministry of Consumer Affairs, Food and Public Distribution, in exercise of powers conferred by Section 3 of the Essential Commodities Act, 1955 (10 of 1955) read with clause 4 and 5 of the Sugar (Control) Order, 1966, permission is granted to following sugar mills and exporter for a total quantity of **3710 MT (Three Thousand Seven Hundred Ten Metric Tons only)** for export to Nepal by 31.10.2022:-
