ORDER

In exercise of powers conferred by section 3 of the Essential Commodities Act, 1955 (10 of 1955) read with clause 4 and 5 of the Sugar (Control) Order, 1966 and Order of the Government of India, Department of Food & Public Distribution vide S.O. No.2347(E) dated 07.06.2018, I, Sangeet, Director (Sugar), Directorate of Sugar & Vegetable Oils, Ministry of Consumer Affairs, Food & Public Distribution, hereby direct that every producer of sugar by vacuum pan process, shall hold white/refined sugar stock tentatively as on 31st October, 2023, until further order, as per the following:-

"Opening stock as on 11.10.2023 Plus (+) Production up to 31st October, 2023 minus (-) Domestic dispatch from 11.10.2023 to 31.10.2023 not exceeding the quantity as mentioned in column (4) of the table below against respective sugar mill:
