Subject: 5th Reallocation of Export Quota for export during Sugar Season 2025-26 and consequent adjustment of Monthly release quantity on account of exchange of export quantity with domestic monthly release quantity.

Madam/Sir,

The Government has allowed the export of 15 LMT of sugar vide letter number 1(4)/2025-SP dated 14.11.2025 along with the modalities for export of sugar.

2. As per clause '4' of the guidelines dated 14.11.2025, DFPD has decided to allow exchange of export quota quantity from the quantity of monthly release quota. In this regard, requests along with agreements between sugar mills involved in exchange of their Export quantity and domestic monthly release quantity have been examined in this Department and accordingly additional export quantity has been allocated and domestic quota of the sugar mills have also been adjusted as mentioned in Annexure.
